"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Western side of Zarline Street, being shown as a major portion of Lot 8, Block B of Sunny Slope Subdivision, plat of which is recorded in Plat Book F at page 86 in the RMC Office for Greenville County, and also being shown as Lot No. 4 on plat of the property of Wilmont Realty Co., Inc., recorded in Plat Book R at page 55, and having the following metes and bounds, to-wit:
