NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 17, according to a plat of property of Broadleaf Forest according to a survey made by Jone's & Sutherland, Engineers, prepared August 1958 and recorded in the R. M. C. Office for Greenville County in Plat Book NN at Page 64 and having, according to said plat, the following metes and bounds, towit:

BEGINNING at an iron pin on the southern side of Forestwood Drive, joint front corner Lots Nos. 16 and 17 and running thence along the joint line of said lots, S. 12-0 E. 136.3 feet to an iron pin in the subdivision line, joint rear corner Lots Nos. 16 and 17; thence along the subdivision line, S. 81-10 W. 80.2 feet to an iron pin, joint rear corner Lots Nos. 17 and 18; thence along the joint line of said lots, N. 12-0 W. 131.4 feet to an iron pin on the southern side of Forestwood Drive, joint front corner Lots Nos. 17 and 18; thence along the southern side of said Forestwood Drive, N. 78-0 E. 80 feet to the point of beginning; being the same conveyed to us by J. Louis Coward Construction Company, Inc. by deed dated August 7, 1959, and recorded in the R. M. C. Office for Greenville County in Deed Vol.
