NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates
Township containing 0.483 Ac., more or less as shown on plat of C.L.
Rodgers, recorded in Plat Book LLL, page 125 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Little Texas Road at the corner of Phillip Witham and running thence N 70-35 W 277.2 feet to an iron pin; thence along Springfield N 55-46 E 188.4 feet to an iron pin on the southwestern side of Little Texas Road; thence with said road, S 28-08 E 224.6 feet to the point of beginning and being the same conveyed to me in Deed Book 788, page 542.

ALSO: ALL of that tract of land, adjoining the above tract, in Bates Township containing 11.44 acres, more or less as shown on plat of Ruth B. Henderson, recorded in Plat Book OO at page 283 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Rifle Range Road at the corner of J.D. and Frances Bigham and running thence along the eastern side of said road, S 26 E 228.3 feet to an iron pin; thence along Bigham, N 64 E 838.6 feet to a point in the line of the above tract; thence S 70-35 E 111.6 feet to an iron pin; thence along Witham and Blackwell S 17-30 W 1191.7 feet to a point in the branch; thence along the branch the following courses and distances to-wit: N 26-45 W 332 feet; N 32-43 W 329 feet; N 31-43 W 231 feet; N 54-08 W 178.5 feet; thence N 44 E 384.2 feet to the point of beginning and being the same conveyed to me in Deed Book 628, page 200 and the southernmost portion is subject to a right of way to the City of Greenville for water lines, recorded in Deed Book 815, page 331.
