until paid; interest to be computed and paid annually and if unpaid when due to

sold and released, and by these presents do grant, bargain, sell and release unto the said
Arthur Williams, his heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being in the City of Greenville,
County of Greenville, State of South Carolina, being known and designated as Lot No.
133 on Plat of Isaqueena Park, which plat is recorded in the R. M. C. Office for
Greenville County, South Carolina, in Plat Book P, pages 130 and 131, and having
according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Kirkwood Lane, joint front
corner Lots 132 and 133 and running thence S. 44-15 W. 166.7 feet to an iron pin;
thence along the line of Lots 119 and 118 N. 37-19 W. 70 feet to an iron pin, joint
