"ALL that certain piece, parcel or lot of land, with all Improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, on the southeast side of the Augusta Road, being known and designated as Lot No. 8 on plat of the property of Albert Q. Taylor made by C. C. Jones in May, 1950, and recorded in the RMC Office for Greenville County in Plat Book "X", at Page 130, and having, according to said plat, the following metes and bounds, to-wit:
