MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Singing Pine Drive shown as Lots 1 and 2 on a Plat of Riverwood, property of Norman S. Garrison, Jr. and Bobby G. Sexton, prepared by C. O. Riddle, R.L.S. recorded in the R.M.C. Office for Greenville County in Plat Book NNN at Page 19 and being further described as follows:

BEGINNING at an iron pin on the eastern side of Singing Pine Drive at the joint corner of Lots 2 and 3; running thence along the line of Lot 3 N 77-50 E 201.7 feet to an iron pin in the line of property now or formerly owned by T. B. Garrison; thence along the line of T. B. Garrison property S 9-34 E 37.5 feet to an iron pin; thence S 12-10 E 162.5 feet, thence S 12-10 E 112.3 feet, thence S 9-20 E 269.4 feet to an iron pin; thence along the curve of the intersection of an unmarked road and the frontage road for I 85, the chord of which is S 65-16 W 15.1 feet; thence along the said frontage road N 54-02 W 233.8 feet to an iron pin; thence N 38-11 W 36.4 feet to an iron pin; thence N 12-10 W 177 feet to an iron pin at the corner of Lot 2; thence along the line of Lot 2 N 12-10 E 200 feet to the point of beginning.
