"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of East Dorchester Boulevard and being known and designated as Lot No. 76, Sections 1 and 2, Belle Meade as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "EE", Pages 116 and 117, reference being hereby specifically made for a more complete description.

The above is the same property conveyed to the mortgagor by deeds recorded in the R. M. C. Office for Greenville County in Deed Book 672, at Page 531 and Deed Book 785, at Page 641.
