"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as lots 3 and 16 in accordance with plat of Lewis C. Godsey, dated Bebruary 21, 1959, recorded in the RMC Office for Greenville County in Plat Book 00 at page 416, and being fully described in accordance with said plat, to-wit:

Beginning at an iron pin on the southwestern side of Bryson Road, joint front corner with Lot 4 and running thence S. 28-28 W. 150 feet to iron pin; thence S. 28-28 W. 153 feet to an iron pin on the edge of new cut street; thence along new cut street N. 62-0 W. 80 feet to an iron pin; thence N. 28-28 E. 158.6 feet to an iron pin; thence continuing in a northeast direction 150 feet to an iron pin on the edge of Bryson Drive; thence along Bryson Drive S. 28-27 E. 80 feet to an iron pin, being the point of beginning.
