All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, on the northwest side of the Spartanburg Road and being a portion of Tract No. 5 of the property of J. F. Freeman as shown on plat thereof recorded in the R. M.C. Office for Greenville County in Plat Book G, at Page 253, and having, according to a survey thereof made by J. L. Hunt and R. K. Campbell on July 19, 1952, the following metes and bounds, to-wit:
