"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being shown as Lot No. 41 on plat of Western Hills recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book QQ at Pages 98-9, and having, according to said plat, the following Metes and bounds, to-wit:
