WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of **Ten Thousand and 00/100** - - - - -

DOLLARS (\$ **10,000.00**), with interest thereon from date at the rate of **Six and Three-Quarter** per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **GREENVILLE**, in the City of **Mauldin**, being situate on the eastern side of **Murray Drive**, and being morefully described in accordance with plat made by **Carolina Engineering and Surveying Company**, dated **May 29, 1967**, described to-wit:

BEGINNING at an iron pin on the eastern side of **Murray Drive**, **102 ft.** from the intersection of **Murray Drive** and **Miller Road** and running thence **N. 81-13 E.**, **100 ft.** to an iron pin; thence **S. 19-56 E.**, **125.4 ft.** to an iron pin; thence **S. 83-02 W.**, **100 ft.** to an iron pin on **Murray Drive**; thence along **Murray Drive**, **N. 20-06 W.**, **122 ft.** to an iron pin, being the point of beginning.
