"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, adjacent to the southwest side of Piney Mountain, on the northeast side of McGee Road, about 16 feet from said road, adjoining lands now or formerly owned by W. T. Eddings on the north, lands of J. P. Griffin on the east and south, and the McGee lands on the west, having the following metes and bounds, as shown on Plat made by J. Earle Freeman, May 4, 1937;

BEGINNING at an iron pin in an old road bed 16 feet from the McGee Road, and running thence N_{\bullet} 41-3/4 E_{\bullet} 3.16 chains to an iron pin in gully; thence S_{\bullet} 43-1/2 E_{\bullet} .80 chains to iron pin; thence S. 51-3/4 W. to iron pin in old road bed; thence N. 43-1/2 W. . 80 chains to beginning corner, containing one-quarter acre, more or less.

BEGINNING at an iron pin, joint corner of Tracts 1 and 2, and running thence N. 72-25 E. 447 to an iron pin; thence S. 8-00 W. 646.8 feet to an iron pin; thence S. 19-00 E. 670 feet to an iron pin; thence S. 63-08 W. 69.1 feet to an iron pin; thence N. 69-58 W. 140.5 feet to an iron pin at joint corner of Tracts 1 and 2; thence along the eastern boundary of Tract No. 2, N. 3-51 E. 1124.6 feet to an iron pin at the beginning point. Said tract contains 9.00 acres, more or less.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
