All that certain parcel or lot of land situated on the west side of North Main Street in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, and being Lot No. 6 and a portion of Lot No. 5 of the property of M rgaret M. Green according to survey and plat by H.L. Dunahoo, Surveyor, dated June 2, 1947, and being particularly shown as the property of Melvin L. Burdette according to survey and plat thereof by B. B. Waters, Jr., Registered Surveyor, dated March 27, 1950, and having rhe following courses and distances, to-wit:

BEGINNING at an iron pin on the west sdie of North Main Street Extension, corner of Lot No. 5 according to amended survey, and 287.5 feet northward from the intersection of North Main Street Extension and Wilson Street, and running thence along the new line of Lot No. 5, S. 66.15 W. 150 feet to an iron pin; thence N. 23.45 W. 62.5 feet to an iron pin, corner of Lot No. 7; thence along the line of Lot No. 7, N. 66.15 E. 150 feet to an iron pin on the west side of North Main Street Extension; thence along said North Main Street Extension, \$ 23.45 E. 62.5 feet to the beginning corner.
