T. Chastain and Mary R. Chastain and their heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the northern side of Holly Circle Extension near the City of Greer, and being shown as Lot No. 2 on a plat of property made for J. R. Friddle by John A. Simmons, Surveyor, dated June 20, 1960, and having the following courses and distances.

BEGINNING at an iron pin on the northern side of Holly Circle Extension at the rear corner of Lot No. 1 and the front corner of Lot No. 2, and runs thence N. 75-40 W. 101.7 feet along the northern side of Holly Circle Extension; to an iron pin at the front corner of Lot No. 3; thence N. 3-45 E. 174 feet as the common line of Lots Nos. 2 and 3 to a point on the line of the Greer Broadcasting Company property; thence S. 86-15 E. 100 feet along the line of said Company property to an iron pin at the rear corner of Lot No. 1; thence S. 3-45 W. 192.7 feet along the rear line of Lot No. 1 to the beginning corner.
