TO ALL WHOM THESE PRESENTS MAY CONCERN: JOHN ANDREW KRAMER III and  
CHARLOTTE WILLIAMS KRAMER

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Sixteen Thousand Eight Hundred and No/100-----  
DOLLARS (\$ 16,800.00 ), with interest thereon from date at the rate of six and one-half per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southerly side of Woodvale Avenue in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 235 as shown on a plat entitled "Second Revision of Traxler Park," prepared by R. E. Dalton, Engineer, dated March, 1923, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "F" at pages 114 and 115, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southerly side of Woodvale Avenue at the joint front corner of Lots Nos. 227 and 235, and running thence with the line of Lots Nos. 227, 228, 229, and 230 S. 57-40 E. 266.24 feet to an iron pin at the joint rear corner of Lots Nos. 235, 230, and 231; thence with the line of Lot No. 230 N. 62-34 E. 17.4 feet to an iron pin at the joint rear corner of Lots Nos. 235 and 236; thence with the line of Lot No. 236 N. 25-23 W. 225 feet to an iron pin on the Southerly side of Woodvale Avenue; thence with the Southerly side of Woodvale Avenue S. 64-37 W. 165 feet to the point of beginning.
