"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

All those certain lots of land lying in the State of South Carolina, County of Greenville on South Washington Avenue shown as Lots # 17 and 18 on a plat of property of the American Bank and Trust Company recorded in Plat Book F at Page 192 in the RMC Office for Greenville County.
