ALL that certain piece, parcel or lot of land, with all the improvement s thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as all of Lot 20 and 15 feet of the Southeastern portion of Lot 19 of a subdivision known as East Lake as shown on plat thereof being recorded in the RMC Office for Greenville County in Plat Book G, at page 229 and having, according to said plat, the following metes and bounds, to-wit: BEGINNING at a point on the Northeastern side of East Circle Avenue, which point is 15 feet Northwest of the joint corner Lots 19 and 20, running thence with East Circle Avenue South 52-45 East 75 feet to an iron pin, joint corner Lots 20 and 21; thence with the joint line of said lots North 37-15 East 156.2 feet to an iron pin at the joint rear corner Lots 21 and 20; thence North 53-22 West 75 feet to a point in the rear line of Lot 19; thence with a new line through Lot 19 South 87-15 West approximately 155.3 feet to the point of BEGINNING.
