November 1, 1982 NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southern side of Parker Road in Monaghan Mills Village, Greenville County, South Carolina, being more particularly described as the Western portion of Lot No. 123, Section 2, as shown on a plat entitled "Addition to a Subdivision for Victor-Monaghan Mills, Greenville, S. C.", prepared by Pickell & Pickell, Engineers, dated September 2, 1952, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book CC at page 173 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Parker Road 122.7 feet in an Easterly direction from the Southeastern corner of the intersection of Parker Road and YMCA Street at the joint front corner of Lots Nos. 123 and 124, and running thence with the line of Lot No. 124 S. 8-28 W. 179.9 feet to an iron pin; thence S. 82-56 E. 55 feet to an iron pin; thence along a new line through Lot No. 123 N. 8-28 E. 178.5 feet, more or less, to an iron pin on the Southern side of Parker Road; thence with the Southern side of Parker Road N. 82-02 W. 55 feet to the point of beginning.
