TO ALL WHOM THESE PRESENTS MAY CONCERN: WE, PAUL W. DACUS & MILDRED C. DACUS

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Fifteen Thousand ----- DOLLARS (\$ 15,000.00 ), with interest thereon at the rate of six & 1/4 per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being at the southerly corner of the intersection of Timber Lane and Woodberry Way, near the city of Greenville, S. C., being shown as Lot No. 21 on the plat of Hollyvale as recorded in the RMC Office for Greenville County in plat book Y at page 131, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southeasterly side of Woodberry Way at the southerly corner of the intersection of Woodberry Way and Timber Lane, and running along the southeasterly side of Woodberry Way, the following courses and distances: S. 26-06 W. 36 feet to an iron pin; S. 22-25 W. 95 feet to an iron pin; S. 19-33 W. 35.7 feet to a point, joint corner of Lots 21 and 22; thence turning and running with the joint line of said lots S. 57-46 E. 202.8 feet to an iron pin in the line of Lot 31; thence turning and running with the line of Lot 31, N. 57-05 E. 85.8 feet to an iron pin on the southwesterly side of Timber Lane; thence turning and running with the southwesterly side of Timber Lane N. 33-05 W. 258 feet to an iron pin at the southerly corner of the intersection of Timber Lane and Woodberry Way, thence around said intersection on a curve, the arc of which is S. 86-49 W. 41.7 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
