"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Stonehaven Drive, in the City of Greenville, being shown as Lot 103 on plat of Property of Tully P. Babb, recorded in Plat Book QO at Page 163, and described as follows:
