TO ALL WHOM THESE PRESENTS MAY CONCERN: C. A. N. ENTERPRISES, INC.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- Four Hundred Forty-Five Thousand and No/100 ----- DOLLARS (\$ 445,000.00), with interest thereon at the rate of 6 1/2 per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 19 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern corner of Sulphur Springs Road and Hiwassee Drive, in Berea Township, near the City of Greenville, and further described as follows:

"BEGINNING at an iron pin at the southwestern corner of the intersection of Hiwassee Drive and Sulphur Springs Road, and running thence with the northwestern side of Sulphur Springs Road, S. 21-18 W. 450 feet to an iron pin; thence N. 68-42 W. 370 feet to an iron pin; thence N. 29-55 W. 254.8 feet to an iron pin; thence N. 59-30 E. 490 feet to an iron pin on the southern side of Hiwassee Drive; thence with the curve of the southern side of said Drive, the chords of which are S. 30-30 E. 86.4 feet, S. 49-36 E. 127.2 feet, and S. 68-42 E. 86.3 feet to the beginning corner."

Being the same property conveyed to the mortgagor by deed recorded in Deed Book 781 at Page 566 in the R. M. C. Office for Greenville County, and also in Deed Book 823 at Page 391.

The execution of this mortgage was duly authorized by resolution of the Board of Directors of the Corporation.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
