Bank of Greer, Greer, S.C., it's successors and assigns forever:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereinafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greer, Chick Springs Township, lying on Laurel Road, being shown and designated as Lot No. 39 on a plat of Burgiss Hills, Incorporated, recorded in the R.M.C. Office for Greenville County in Plat Book "Y", at pages 96 and 97, having the following courses and distances.
