"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, located on the north isde of the Tugaloo Road(State Highway No. 414), being shown on a plat made for the mortgagors by Terry T. Dill, Surveyor, dated September 30, 1967, to be recorded herewith, and having the following courses and distances:
