To All Whom These Presents May Concern: We, Maxwell Dunn and Girstine
Dunn, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Town-
ship near the Old Ansel School House, being a part of Tract No. 6
as shown on a plat of John M. and Frances Jane A. Greer Estates, said plat made by H.S. Brockman, Surveyor, December 30, 1941, having the following courses and distances:

BEGINNING on an iron pin, joint corner of Tracts Nos. 7 and 8, on line of Tract No. 6, and runs thence with line of Tracts Nos. 6 and 7, S. 2-20 W. 150.5 feet to iron pin; thence N. 81-05 E. 150 feet to an iron pin on common line of Tracts Nos. 4 and 6; thence with said line, N. 2-20 E. 150.5 feet to an iron pin; thence S. 81-05 W. 150 feet to the beginning corner, containing 52/100 acres, more or less.
