NOW KNOW ALL MEN, that in consideration of said loan and to further secure the payment of said Note and also in consideration of three dollars (\$3) to the Mortgagors in hand well and truly paid by Mortgagee at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, the Mortgagors hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate, situated in the County of Greenville, State of South Carolina, to-wit: On the southern side of Gower St. and being known and designated as Lot No. 4,

on a plat of property of W.O. Groce as made by R.E. Dalton, Engineer, in March, 1966, which plat is of record in the RMC Office for said county and state in plat Book Q, at page 188, said property being described by metes and bounds as follows: BEGINNING at an iron pin on the southern side of Gower St. at the corner common to lots 3 and 4 as shown on said plat and running thence S. 30-36W. along the dividing line between said Lots 3 and 6, 130 ft. to an iron pin; thence N. 59-24 W. 52 ft. to an iron pin at the corner of lot 5; thence N. 30-36 E. along the dividing line of lots 4 & 5 130 ft. to an iron pin on the southern side of Gower St.; thence S. 59-24 E. along the southern side of Gower St. 52 ft. to the place of beginning.

To have and to hold, with all and singular the rights, members, benefits and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue. Upon default in making any payment of said Note when the payment becomes due, then the entire sum remaining unpaid on said Note shall be due and payable by the exercise of the option of acceleration above described, and this Mortgage may be foreclosed as provided by law for the purpose of satisfying and paying the entire indebtedness secured hereby.
