NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 50 of a subdivision known as Cedar Terrace as shown on a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book BBB at Page 137 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the northern side of Pinehurst Drive at the joint front corner of Lots 50 and 42 and running thence with the curvature of said drive, the chord being S. 63-26 W. 118.6 feet to an iron pin on the northern edge of Ellen Lane; thence with the curvature of Ellen Lane, the chord being N. 76-38 W. 106 feet to an iron pin at the joint corner of Lots 50 and 49; thence along the line of Lot 49, N. 39-07 E. 133.6 feet to an iron pin; thence along the line of Lot 43, N. 45-09 E. 15 feet to an iron pin, joint rear corner of Lots 50 and 42; thence along the line of Lot 42, S. 52-53 E. 143.6 feet to the beginning corner; being the same conveyed to us by Harry H.
