TO ALL WHOM THESE PRESENTS MAY CONCERN:

W. N. Leslie, Inc. -----(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-one Thousand Five Hundred and No/100 -----
DOLLARS (\$21,500.00 -----), with interest thereon from date at the rate of Six and Three-fourths per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the northern side of Hillsborough Drive near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 44 of a subdivision known as Merrifield Park, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 000 at Page 177 and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Hillsborough Drive at the joint front corner of Lots Nos. 43 and 44 and running thence with the joint line of said lots N. 19-00 E., 180 feet to an iron pin; running thence S. 71-00 E., 110 feet to an iron pin at the joint rear corner of Lots Nos. 44 and 45; running thence with the joint line of said lots S. 19-00 W., 180 feet to an iron pin on the northern side of Hillsborough Drive; running thence with the northern side of said drive N. 71-00 W., 110 feet to an iron pin, point of beginning.
