To All Whom These Presents May Concern:

I, Kenneth D. Styles

SEND GREETING:

WHEREAS, I the said Kenneth D. Styles

in and by my certain promissory note in writing of even date with these Presents, and well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of four thousand five hundred and no/100 - - - - - (\$ 4,500.00) Dollars, with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

sixty five and no/100 - - - - - (\$ 65.00) Dollars due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That I the said Kenneth D. Styles, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor, in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal

Township, described as follows:

BEGINNING on a pin in the road leading to Locust Hill Church, and runs thence with the road as the line, N. 63-40 E., 211 feet to a pin; thence S. 31-20 E., 209 feet to a stake; thence S. 63-00 W., 225 feet to a stake; thence N. 27-28 W., 209 feet to the beginning point, containing one (1) acre, more or less and is the same property conveyed to J. D. Styles by Emma Lee Bishop, by deed recorded in deed book 599, page 546, Greenville County R. M. C. Office.

This is the same property conveyed to me by deed by J. D. Styles dated May 11th, 1963 and recorded in the R. M. C. Office for Greenville County in Book 722, page 454.
