"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near Ebenezer Church, Bates Township, and according to Plat of Lots of H. D. Burns Surveyed by Terry T. Dill, dated Oct. 30, 1967, having the following metes & bounds, to-wit:

BEGINNING at a point on White Horse Road and running N 10-15 E. 152.1 ft. to a point; thence S. 44-00 E. 285.5 ft. to a point, along the line of T. E. Coleman property; thence S. 21-22 W. 21.0 ft. to a point; thence N. 71-15 W. 231.0 ft. to the point of the beginning.
