MORTGAGE OF REAL ESTATE

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, on the West side of Old Greenville Road, about one mile South of State Highway 414, being shown as containing 15.2 acres on a plat of property prepared for Hubert Gosnell, by  $\overline{J}$ .Q. Bruce, Surveyor, dated July 14, 1967, recorded in Plat Book GGG at page 573, and having such metes and bounds as is thereby shown. Reference to said plat and record thereof being hereby made of a more detailed description of said property.

Subject however to the life estate in a small lot reserved to Luther and Martha Stanton, as described in Vol. 674 at page 522.
