We, Thomas J. Allen and Janice G. Allen SEND GREETING:

WHEREAS, we the said Thomas J. Allen and Janice G. Allen
in and by our certain promissory note in writing of even date with these Presents, are well
and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of
fourteen thousand five hundred and no/100 - - - - - (\$ 14,500.00) Dollars,
with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to
bear interest at the same rate, to be repaid in installments of

one hundred thirty and 34/100 - - - - - (\$ 130.34) Dollars

aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION,
Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00)
Dollars to us the said mortgagors in hand well and truly paid by the said mortgagee, at and
before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained,

Estate, made by H. S. Brockman, surveyor, dated November 6, 1952 and amended Feb.
25, 1956, recorded in the R. M. C. Office for Greenville County in plat book JJ page
127, and having according to a recent survey by T. C. Adams, Eng. the following metes
