"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeast side of Aberdeen Avenue, near the City of Greenville, being shown as Lot 41 on Maps 2 and 3 of Park Hills, said plat being recorded in the RMC Office for Greenville County in Plat Book I at pages 35, 36 and 37 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southeastern side of Aberdeen Avenue 75 feet from the southeast corner of the intersection of said Avenue and a 50-foot street and running thence along Aberdeen Avenue, S. 27-10 W. 75 feet to an iron pin corner of Lot 42; thence with line of said lot, S. 62-50 E. 160 feet to an iron pin in line of Lot 14; thence with line of said lot, N. 32-55 E. 75.4 feet to an iron pin, corner of Lot 40; thence with line of said lot, N. 62-50 W. 167.5 feet to the point of beginning.
