"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Fernwood Drive and being known and designated as Lot No. 31 on plat of Section 4 of Edwards Forest Subdivision, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "JJJ", at Page 82 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Fernwood Drive, joint front corner of Lots Nos. 31 and 32 and running thence with the common line of said lots S. 33-15 E. 154.5 feet to an iron pin; thence with the rear line of Lot No. 31 S. 54-58 W. 100.4 feet to an iron pin; thence with the common line of Lots Nos. 30 and 31 N. 33-15 W. 167 feet to an iron pin on the southern side of Fernwood Drive; thence with said Drive N. 61-05 E. 100.3 feet to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
