"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of East Washington Street in the City of Greenville, and according to a survey made by J. C. Hill on November 4, 1959, is described as follows:

Beginning at an iron pin on the southern side of East Washington Street 120 feet west from Mordecia Street, and running thence S 17-45 W 172 feet to an iron pin; thence N 70 W 3 feet to an iron pin; thence N 7-30 W 12.2 feet to an iron pin; thence N 70-30 W 51 feet to an iron pin; thence N 17 E 157 feet to an iron pin on East Washington Street; thence with the southern side of said Street, S 71-30 E 60 feet to the beginning corner. Being the same property conveyed to the mortgagor by Deed Book 313, page 20.
