WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----
Twenty-two Thousand Five Hundred and no/100----- DOLLARS
(\$ **22,500.00---**), with interest thereon at the rate of ~~per cent~~ per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is **twenty** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the western side of Chateau Drive, being shown as Lot 131 on plat of Merrifield Park recorded in Plat Book 000 at page 177, and having according to said plat the following metes and bounds:**

Beginning at an iron pin on the joint front corner of Lots 131 and 130 and running thence with line of Lot 130, N 88-20 W 175 feet to an iron pin in line of Lot 143; thence with line of Lot 143, N 1-40 E 110 feet to an iron pin at rear corner of Lot 132; thence with line of said lot, S 88-20 E 175 feet to an iron pin on the western side of Chateau Drive; thence with the western side of said Drive, S 1-40 W 110 feet to the beginning corner.
