"ALL that certain piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. 6, of the C. F. Putman Property, said plat being recorded in the RMC Office for Greenville County in Plat Book F at page 240, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at the joint front corner of Lots Nos. 6 and 7 and running thence N. 34-15 E. 200 feet to a point; thence N. 55-45 W. 67 feet to a point; thence S. 34-15 W.200 feet to a point; thence S. 55-45 E., 67 feet to the point of beginning.

ALL that certain lot of land in Greenville County, State of South Carolina, in the City of Greenville, being known and designated as the rear portion of Lot No. 7 as shown on a plat of the property of C. BEGINNING at an iron pin on the Northwest side of LaneAvenue, which pin is 150 feet northeast of the intersection of Lane Avenue and Laurens Road, and running thence with said Avenue N. 45-15 W. 64 feet to an iron pin at joint corner of Lots 16 and 7; thence with the line of Lot 16, N. 55-45 W. 139 feet to an iron pin in line of Lot 6; thence with the line of Lot 6, S. 34-15 W. 50 feet to an iron pin; thence through Lot 7, in a southeasterly direction in a straight line to the point of beginning.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
