All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **Cleveland Township**, known as **Lot Nos. 10, 11, 12 on Table Rock Road** being a part of the **Clara Bates Turner Property** recorded in Plat Book PP, page 160 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of said Road at the corner of Lot No. 9 and running thence S 35 E 478 feet to a point in the center of S.
