to be paid *one year from date*

with interest thereon from *Date* at the rate of *7%* per centum per annum, to be computed and paid *annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee, *William*

J. Henson and his heirs and assigns:

All of that parcel or lot of land in Butler Township of Greenville County, State of South Carolina, located about 2 1/2 miles from Bushy Creek Baptist Church and lying between two County Roads and near the intersection of same, being a portion of tract of land shown on a Plat of Property made for Mrs. Leonard Howard by C. O. Reddick, Recorder in Plat Book NN at Page 19. S. M. C. officers of Greenville County, and having the following courses and distances to wit:

Beginning at a Point in the center of County Road, the Southwestern corner of the lot conveyed herein (iron pin on east bank of lot at 19.7 feet) and runs thence S 87-47 E. 234.1 feet to a point in other County road (iron pin on western bank thereof at 25.6 feet); thence with said County Road, N 32-29 E. 111 feet to a point on the Eastern edge of road (iron pin on Western bank thereof at 36.9); thence N 57-20 W 333.6 feet to a point in the center of other County Road (iron pin on east bank thereof at 25.3 feet);
