"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, in the Piedmont Manufacturing Company Village, in or near the town of Piedmont, and being more particularly described as Lot No. 106, Section 3, as shown on a plat entitled "Property of Piedmont Mfg. Co.", Greenville County, made by Dalton & Neves, February 1950; Sections 3 and 4 of said plat are recorded in the R.MC. Office for Greenville County in Plat Book &, at pages 2-5, inclusive, and pages 6-9, inclusive, respectively.
