TO ALL WHOM THESE PRESENTS MAY CONCERN:

W. F. Newsome and Doris Law Newsome

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Greenville County, South Carolina, known and designated as Lot No. 4, as shown on a plat of the subdivision of ADDITION TO WILDAIRE ESTATES, recorded in the R. M. C. Office for Greenville County in Plat Book RR, Page 100, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northerly side of Edwards Road, which iron pin is the joint front corner of Lots Nos. 3 and 4 and running thence N. 4-40 W. 214.0 feet to an iron pin; thence N. 75-52 E. 61.6 feet to an iron pin; thence N. 77-45 E. 39.0 feet to an iron pin; thence S. 4-39 E. 225.0 feet to an iron pin on the northerly side of Edwards Road; thence S. 77-40 W. 11.2 feet to an iron pin; thence continuing along Edwards Road, S. 84-13 W. 86.8 feet to an iron pin, the point of Beginning.
