(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south-westerly side of Heathwood Circle, near the town of Taylors, and being designated as Lot No. Seventy-one (71) on plat of Heathwood as recorded in the R. M. C. Office for said County in Plat Book KK, page 35, and having, according to said plat the following metes and bounds, to-wit: Beginning at an iron pin on the southwesterly side of Heathwood Circle joint front corner of lots nos. 71 and 72, and running thence along the common line of said lots S.66-07 W.200 feet to an iron pin; thence N.23-53 W.100 feet to an iron pin, joint rear corner of lots nos. 70 and 71; thence along the common line of said lots N.66-07 E. 190 feet to an iron pin on the southwesterly side of Heathwood Circle; thence along said Circle S.36-24 E.46 feet to an iron pin; thence continuing with said Circle S.23-53 E.55 feet to an iron pin, the point of beginning.
