"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, in section known as Northgate Heights, fronting 70 feet on the North side of Montclair (formerly West Fairview Avenue) being shown as Lot 7 and part of Lot 8 on a plat of Highland Terrace, recorded in Plat Book K at pages 120-122, and being more particularly described as follows:

BEGINNING at an iron pin at the joint front corner of lot now or formerly owned by O. W. Dixon, said pin being 310.2 feet west of the Northwest corner of intersection of Montclair Avenue and Water Street, and running thence N. 80-08 W. 70 feet along Montclair Avenue to a pin at corner of Lot now or formerly owned by Sadie Huff; thence N. 9-52 E. 150 feet to a pin on a 12 foot alley; thence with said alley S. 80-08 E. 70 feet to a pin; thence S. 9-52 W. 150 feet to the point of Beginning.
