"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville. All that certain lot of land in Greenville Township, Greenville County, State of South Carolina known and designated as lot No 28 on plat of property of F. B. Massingale made by C. Coke Smith, May 15, 1917 and km having the following metes and bounds according to said plat:

BEGINNING at a stake on the south side of arch Street Extension at corner of Lot No 29, and running thence with line of lot No 29 in a southeastermy direction 226 feet to a stake; thence S 60-25 W 60 ft to stake at cornerof Lot No 27; thence in a northwesterly direction with line of lot No 27, 226.7 ft to stake on Arch Street Extension; and thence with arch Street Extension N 60-25 E 60 feet to the beginning corner.
