To All Whom These Presents May Concern: WOOTEN CORPORATION OF WILMINGTON

Dollars, in and by its certain promissory note in writing, of even date herewith, due and payable

on demand, six months from date

with interest from date, at the rate of eight

percentum until paid; interest to be computed and paid monthly, beginning six months after date

All that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, on the northern side of Lanewood Drive at the intersection of Lanewood Drive and Clearfield Road, being known and designated as Lot 28 on plat of Pineforest Subdivision recorded in the R. M. C. Office for Greenville County in Plat Book QQ, Pages 106-107, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Lanewood Drive at the joint front corner of Lots 28 and 29, and running thence with the joint line of said lots N. 26-30 W. 138 feet to an iron pin; thence S. 63-30 W. 150 feet to an iron pin on the eastern edge of Clearfield Road; thence with Clearfield Road S. 26-30 E. 113 feet to a point; thence with the curve of the intersection of Clearfield Road and Lanewood Drive S. 71-30 E. 35.3 feet to a point on the northern side of Lanewood Drive; thence with Lanewood Drive N. 63-30 E. 125 feet to the point of beginning.
