"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Dunean Mill Village, being designated as Lot 83, Section 3, as shown on plat of Dunean Mills recorded in Plat Book S at pages 173-177, inclusive, and according to said plat, the within described lot also known as 4 Duke Street and has a frontage on Duke Street of 79.5 feet.

This is a purchase money mortgage given to secure the balance due on the purchase price of the within described property.
