TO ALL WHOM THESE PRESENTS MAY CONCERN: THOMAS RANDALL MOORE

Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto CAMERON-BROWN COMPANY

State of South Carolina: on the northern side of Amy Lane (formerly Braddock Street) and being known and designated as Lot No. 203 of Section VI of Colonial Hills Subdivision, plat of which is recorded in the R.
