SEND S GREETING:

Whereas, I, the said Robert H. Yeargin
in and by my certain promissory note in writing, of even date with these
presents, am well and truly indebted to Walter W. Goldsmith and A. Foster McKissick,
as Trustees for R. M. Caine, et al. under Trust Agreement dated April 29, 1967,
in the full and just sum of SEVENTY THOUSAND SEVEN HUNDRED EIGHTY-EIGHT AND NO/100THS
DOLLARS
(\$70,788.00) /, to be paid December 1, 1971

, with interest thereon from date
at the rate of seven per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in
the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder
thereof necessary for the protection of his or its interests to place, and the holder should place, the said note
or this mortgage, in the hands of an attorney for any legal proceedings, then and in either of said cases the

TRUST AGREEMENT DATED APRIL 29, 1967:

All that piece, parcel or tract of land situate, lying and being on the
