The debt secured by the above abstracted mortgage having been paid in full, the Clerk of Court for Greenville County is authorized to cancel and satisfy the same of record.

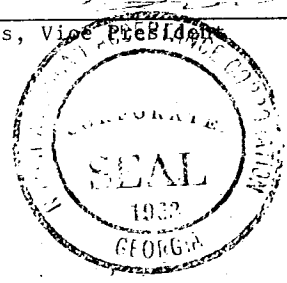
