ALL that piece, parcel or lot of land in Oaklawn Township, Greenville County, State of South Carolina, containing 1.09 acres, more or less, being known as parts of Lots Nos. 6, 7 and 8 on plat of property of C. F. Putman and F. G. Mauldin recorded in the R. N. C. Office for Greenville County in Plat Book F, at Page 239, and having, according to a plat made by E. E.
