TO ALL WHOM THESE PRESENTS MAY CONCERN:

BLEASE G. COLEMAN and ALICE E. COLEMAN of  
Greenville County, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto CAMERON-BROWN CO.,  
900 Wade Avenue, Raleigh, North Carolina

, a corporation organized and existing under the laws of the State of North Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of NINE THOUSAND SEVEN HUNDRED & NO/100 ----- Dollars (\$9,700.00), with interest from date at the rate of SEVEN & ONE-HALF per centum ( 7½ %) per annum until paid, said principal and interest being payable at the office of CAMERON-BROWN CO., 900 Wade Avenue in Raleigh, North Carolina or at such other place as the holder of the note may designate in writing, in monthly installments of ----- SIXTY-SEVEN & 90/100 ----- Dollars (\$ 67.90 ), commencing on the first day of August, 1969, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of July, 1999.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina:

ALL that certain piece, parcel, or lot of land, with the improvements thereon, situate, lying, and being on the southeastern side of Perry Road, Greenville County, South Carolina, which is known and designated as Lot 6 of the property of L. A. Moseley, as shown on a plat of that property recorded in the Office of the R. M. C. for said County in Plat Book "J", Page 239, and which is described more particularly as follows.

BEGINNING at an Iron pin on the southeastern side of Perry Road, joint front corner of Lots 5 and 6, and running thence S. 46-45 E., 145 feet to an iron pin; thence S. 43-15 W., 60 feet to an iron pin; thence N. 46-45 W., 145 feet to an iron pin; and, thence N. 43-15 E., 60 feet to an iron pin, the point of beginning.
